**SUBJECT:** Memo #17-10, New Income Limits & Recapture Tax Notice

---

As required by federal tax law, NIFA has adopted new family income limits based on 2017 limits published by the Department of Housing and Urban Development. Please note the limits decreased in Saunders and Seward counties and increased in all other counties.

***The 2017 income limits are included on the attached Appendix I and take effect for all loans with a reservation date in Lender Online (LOL) on and after July 14, 2017.***

Participating Lenders should adhere to the following instructions as we transition from using the Initial/Final Notice of Recapture Tax (Form D) dated 08/2016 to the revised Form D dated 07/2017:

- Loan reservations dated prior to July 14, 2017. All borrowers should sign Form D dated 08/2016 at loan application and closing. We will retain this form in LOL until all loans make it through the purchase cycle.
- Loan reservations dated on and after July 14, 2017. Participating Lenders may begin using Form D dated 07/2017 at loan application. ***NIFA will require borrowers to sign the revised Form D at closing.*** We will accept borrower signatures using Form D dated 08/2016 at loan application only in situations where the Participating Lender is in the process of making the necessary changes to their loan origination system.

The revised Form D is available in LOL as a PDF document and is available in Word format upon request.
